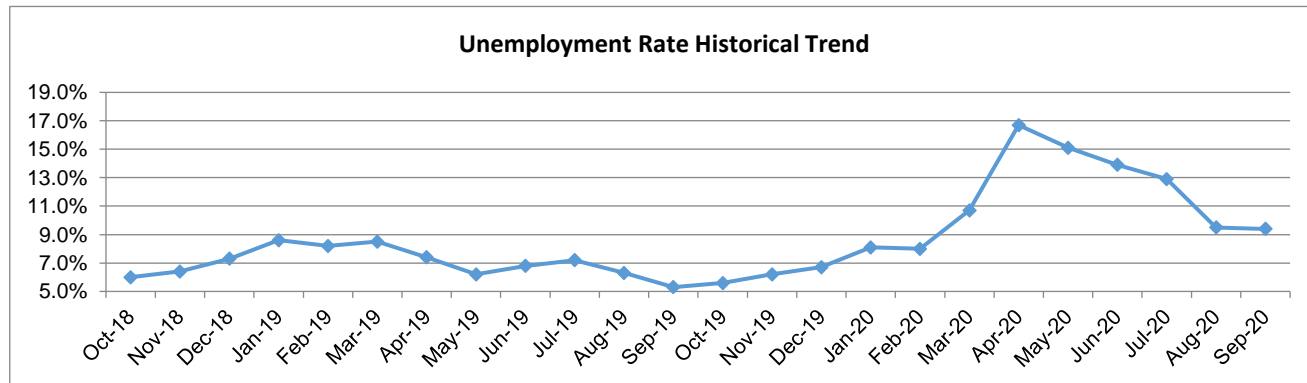


IMMEDIATE RELEASE
 MADERA METROPOLITAN STATISTICAL AREA (MSA)
 (Madera County)

The unemployment rate in the Madera County was 9.4 percent in September 2020, down from a revised 9.5 percent in August 2020, and above the year-ago estimate of 5.3 percent. This compares with an unadjusted unemployment rate of 10.8 percent for California and 7.7 percent for the nation during the same period.
