

IMMEDIATE RELEASE NAPA METROPOLITAN STATISTICAL AREA (MSA) (Napa County)

The unemployment rate in the Napa County was 7.6 percent in September 2020, down from a revised 8.0 percent in August 2020, and above the year-ago estimate of 2.3 percent. This compares with an unadjusted unemployment rate of 10.8 percent for California and 7.7 percent for the nation during the same period.
