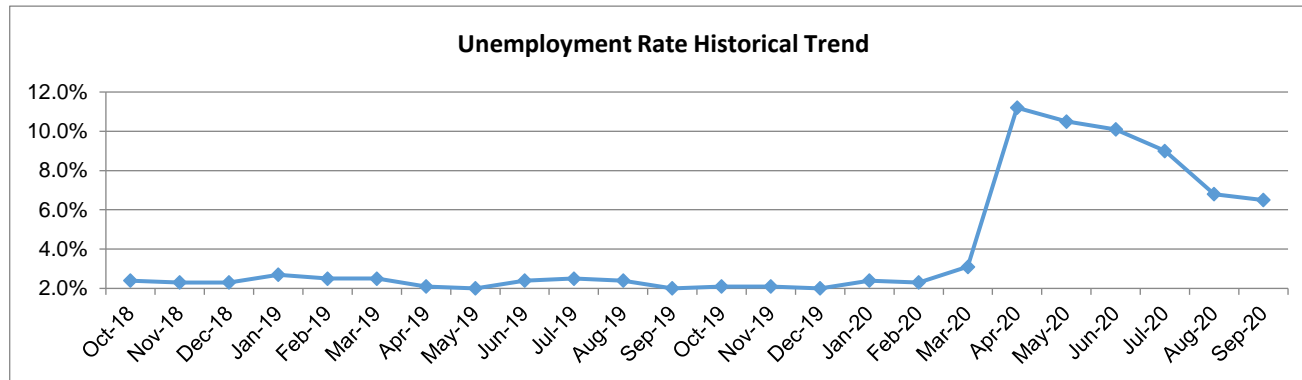

The unemployment rate in the Marin County was 6.5 percent in September 2020, down from a revised 6.8 percent in August 2020, and above the year-ago estimate of 2.0 percent. This compares with an unadjusted unemployment rate of 10.8 percent for California and 7.7 percent for the nation during the same period.
